Plus, extensive information is provided for the firm's managing partners, including their titles, education (degrees and schools), professional background (previous positions and companies), and current directorships held. Many firms operate from multiple locations, and these other branches are also included in the company listing.

The firms in *The Directory of Venture Capital & Private Equity Firms* are organized into two major sections, Domestic and International. Each is arranged alphabetically by company name. The directory also contains five easy-to-use, cross-referenced indexes, putting this vast array of information at the user's fingertips immediately. The College/University Index offers an alphabetical list of 979 educational institutions worldwide, and the key executives who attended them, complete with the reference number of the affiliated firm. The Executive Index lists key personnel alphabetically by last name, and includes the affiliated firm's reference number. The Geographic Index organizes all companies domestically by state and, internationally by country. The Industry Preference Index alphabetically lists 230 industry segments and the firms that invest in them. The Portfolio Companies Index alphabetically lists all the companies that received venture capital from a listed firm, and each company is referenced to that firm.
